Jessica Bulger, CEO Australian Indigenous Governance Institute

SPEAKERS

JESSICA BULGER

CEO, Australian Indigenous Governance Institute and Co-Chair Outward Bound Australia Board



Jess is currently the CEO of the Australian Indigenous Governance Institute (AIGI), and Co-Chair at Outward Bound Australia, and is based in Canberra. She began her career as a teacher and taught within High Schools and Universities before moving into the NFP sector where her focus has been on governance, women in leadership and nurturing emerging leaders. Jess also holds various advisory roles related to initiatives she cares about including with DFAT, Monash University, Philanthropy Australia, GHD and Optus. In her spare time, Jess is taking her young family on adventures or supporting the passions and projects of her Mum and Aunties at home in Tumut. Jess comes from a long line of strong Wiradjuri women and is driven by the belief that as Indigenous peoples we have the solutions for our communities and that our work must be informed by the teachings of our Elders.

SALLY KUSCHEL

Assistant Coordinator-General for National Emergency Management (NEMA)



Sally joined NEMA in January 2024 as Assistant Coordinator, Strategy and Resilience Policy. Sally has been involved with disaster and climate resilience policy since 2016 at the Department of the Prime Minister and Cabinet, former Emergency Management Australia, and the first National Resilience Taskforce. Sally led the team that developed the National Disaster Risk Reduction Framework. Sally has worked in the Australian Public Service for two decades on a range of law and justice policy issues, and before that as a commercial lawyer. Most recently, Sally was part of taskforce that developed the Australian Government's Response to the Robodebt Royal Commission. Sally values working collaboratively to get the best outcomes, and appreciates the opportunity NEMA has to work with diverse stakeholders to help reduce harm and suffering for Australian communities.

JOHN RICHARDSON

Executive Director, Australian Institute for Disaster Resilience (AIDR)



John Richardson is the Executive Director of the Australian Institute for Disaster Resilience, Australia's national disaster risk reduction and resilience institute. He has worked in disaster management since 1997, in range of roles including the State Recovery Manager for Victoria in the early 2000s, and more recently the National Resilience Adviser for Australian Red Cross. He also is an Honorary Fellow of the University of Melbourne in the Melbourne School of Global and Public Health and has represented Australia in International flora. He has qualifications in Geography, Nursing and Environmental Science, and is a publisher, author and blogger. 35 years ago he completed the Summit to Sea Outward Bound 28-day course, from Mt Kosciuszko to Cape Conran. He has a keen interest and eye for patterns and connections in disasters, both at a practice and a policy level.

DR GRANT LYNCH

University of Sydney and CEO, EMU Systems



Dr Grant Lynch is a Postdoctoral Research Associate and Commercialisation and Industry Engagement theme lead for the Heat and Health Research Centre at the Faculty of Medicine and Health at The University of Sydney. His research focuses on the physiological impacts of extreme heat and the development of strategies to reduce heat-related health risks in occupational, sporting, and community settings. He is also the CEO of EMU Systems, a heat stress management startup that provides real-time monitoring and decision-support tools to enhance safety and performance during hot weather.

DR CLARE DALLAT

Founder & Director, Risk Resolve



Dr. Clare Dallat is a globally recognised leader in crisis, risk and safety management. She holds a PhD in Human Factors (Accident Prediction), an MSc in Risk, Crisis and Disaster Management, and is a Chartered OHS Professional. As the Founder and Director of Risk Resolve, Clare applies systems thinking to support educational institutions and government agencies across Australia and internationally. With over 25 years of experience—from field instructor to executive leader—she has contributed to major projects in North America, Europe, the Middle East, and Asia. An Adjunct Industry Research Fellow at the University of the Sunshine Coast's Centre for Human Factors and Sociotechnical Systems, Clare was the first non-North American recipient of the prestigious Reb Gregg Award for her contributions to risk and safety management.

DR KARL BRAGANZA

National Manager for Climate Services, Bureau of Meteorology



Karl joined the Bureau in 2005, following postdoctoral research at Monash University and CSIRO. Karl's contributions include extensive research on understanding climate change and eminence as a leading science communicator. Leading the Climate Monitoring team since 2010, Karl has played a key role in briefing government and key stakeholders on the science of climate change and contributed significantly towards improving the national integration of science, technology and decision making. He has contributed to an improved understanding of climate risk in the emergency management, energy, and water resources sectors, and more recently with the insurance and financial services sector. Karl has undergraduate qualifications in Physics and Dynamical Meteorology from the University of Melbourne (Hons) and a PhD in Climatology (Monash University).

LORI MODDE

CEO Outdoors NSW & ACT



Lori has been a leader in community development for 30 years but what she has accomplished in the last few years is an example of exemplarily leadership for improving an industry and its businesses. Awarded the Outstanding Contribution to the Tourism Industry in NSW in 2023, she has contributed thousands of voluntary hours and held positions of influence enabling major community action and tourism infrastructure that has benefited the Sydney and regional areas of NSW. In late 2023 she was voted in as Chair of the NSW Tourism Industry Council, at a time the tourism industry needed leadership and a voice to encourage collaboration, Lori led the formation of the NSW Tourism Association with 9 other industry leaders to consolidate voice, increase advocacy and securing a better visitor economy in NSW. She is also Chair of Western Sydney Moving which became a Charity in late 2024 and is in her 6th year of leading Outdoors NSW & ACT as the voice for the Outdoor Industry, activating more healthier, resilient and connected communities. In a federal capacity she is the Secretary and Director of the Outdoor Council of Australia.

MARY-JANE MCLEOD

National Community Engagement Lead at the Bureau of Meteorology.



Mary-Jane (MJ) McLeod is the National Lead in the Bureau of Meteorology's Community Engagement Team. The team's objective is to uplift the communities understanding of weather hazards to improve decision making before, during and after weather events. They seek to understand the needs of, and advocate for communities who are more vulnerable to weather hazards, including culturally and linguistically diverse communities, people living with a disability, the elderly, youth and the outdoor sector.

DR JEFF JACKSON

Risk Management Consultant



Dr. Jeff Jackson's work spans risk management and safety planning across industry, government, and the outdoor sector. As an early pioneer in Canada's adventure tourism risk management, his research and consulting has focused on organizational factors that influence individual safety performance. New climate realities have challenged base level assumptions upon which operations assess risk and plan for safety, so offers important new avenues to explore and potentially offer some direction to front line guides, educators, and managers. He recently co-authored a research paper on North America's outdoor sector's readiness for climate change, finding widespread unease but little in the way of modified operations. Jeff was the coordinator and professor at Algonquin College's Outdoor Adventure guide training diploma and has worked as a consultant for more than 20 years, including several projects in Australia for government and the outdoor sector.

PETA WHITE

Climate Change Education Strategy



Peta J. White is an Associate Professor in Science and Environmental Education at Deakin University. She led the OECD PISA Environmental Science contribution to the 2025 Science Framework 'Agency in the Anthropocene' and Co-directs the Centre for Regenerating Futures - a Faculty Centre that explores Anthropocene challenges and decolonising practices while building researcher capacity. She is the Editor-In-Chief of the Australian Journal of Environmental Education. Her current research follows three narratives: science and biology education; sustainability, environmental, and climate change education; and collaborative/activist methodology and research.
